The decrease in loss was mainly due to a combination of the following factors (i) there was no more decrease in fair value of investment properties during the 2024 Interim Period whereas in the corresponding period for 2023 the Group recorded a decrease in fair value of investment properties in the amount of approximately RMB24,271,000; and (ii) the Group achieved modest growth in its revenue and other income during the 2024 Interim Period.

The Company is still in the process of preparing and finalising the Group's interim results for the six months ended 30 June 2024. Shareholders and potential investors are advised to note that the information contained in this announcement is only based on the preliminary assessment by the Board of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2024 which have not been reviewed or audited by the Company's auditors and the information available to the Board as at the date of this announcement.
